## COMPREHENSIVE RESOLUTION OF PATENT ISSUE RELATING TO DIGITAL CABLE TELEVISION BROADCASTERS ULDAGE and Eleven (11) Digital Cable Television Broadcasters Executed License Agreements

ULDAGE Inc., the patent pool license administrator, is pleased to announce that, up to today, Eleven (11) Digital Cable Television Broadcasters as shown below and ULDAGE have executed license agreements for patents relating to (2K) digital cable television broadcasting and ultra-high definition (4K) digital cable television broadcasting (hereinafter collectively referred to as Digital Cable Television Broadcasting):

Digital Cable Television Broadcasting cannot be realized unless both ends exist: the broadcasters which send signals that comply with the CATV Standards and the receivers (STB, etc.) which receive such signals. Consequently, ULDAGE has pursued negotiations with digital cable broadcasters for license program of Digital Cable Television Broadcasting in addition to the license program for the receivers.

As the result, the license agreements with total Thirty-eight (38) digital cable television broadcasters have been entered into since this April when we executed license agreement with JCOM. This clearly shows that the Digital Cable Television Broadcasters duly evaluated the value of the license for Digital Cable Television Broadcasting and recognized its essentiality for their business.

ULDAGE will continue to contribute to maintaining the environment for broadcasting business in a stable manner and make an effort to keep the fair sharing of patent royalties relating to the transmission and receiving of the broadcasting services.
